### Instructions for Tax-Filers

*To obtain an IRS tax return transcript, you can go to [www.irs.gov](http://www.irs.gov) and click on "Get My Tax Record" and then click on "Get Transcript ONLINE." Make sure to request the "IRS Tax Return Transcript" and **NOT** the "IRS Tax Account Transcript." Or you can call 1-800-908-9946.*

*Please note that if you are eligible to use the IRS Data Retrieval Tool to link your taxes to the FAFSA, that this option may limit any current and future request for verification and may result in a quicker resolution of your verification status.*

### Instructions for Non Tax-Filers

*To obtain confirmation of non-filing from the IRS, you can follow the same steps listed above. If the IRS has no record of any 2016 tax return being filed under your Social Security Number, then instead of a tax transcript, you will receive a letter confirming your non-filing.*

*Please note that if you are married, confirmation of filing will be needed for both you and your spouse. If one of you filed and the other did not, we will need a transcript for one and a confirmation of non-filing for the other. If both of you did not file, we will need a confirmation of non-filing for both.*
